Curry (Comptroller of the Currency), Director Richard Cordray (Director, Consumer Financial Protection Bureau), and Chairman Martin J. Gruenberg, that Corporation business required its consideration of the matters which were to be the subject of this meeting on less than seven days' notice to the public; that no earlier notice of the meeting was practicable; that the public interest did not require consideration of the matters in a meeting open to public observation; and that the matters could be considered in a closed meeting by authority of subsections (c) (4), (c) (6), (c) (8), (c) (9) (A) (ii), (c) (9) (B), and

(c) (10) of the "Government in the Sunshine Act" (5 U.S.C. 552b(c) (4), (c) (6), (c) (8), c) (9) (A) (ii), (c) (9) (B), and (c) (10)).

The meeting was held in the Board Room of the FDIC Building located at 550 - 17th Street, N.W., Washington, D. C.
