## A. Overview of Information Collection

<u>Title of Information Collection:</u> Assessment of the HUD Grants to Promote Coordination between Grantees of HUD's Lead Hazard Control Program and DOE's Weatherization Assistance Program.

OMB Approval Number: 2539-Pending.

Type of Request: New request.

Form Number: None.

Description of the need for the information and proposed use: Congress requested HUD to do the following: (1) demonstrate whether the coordination of Healthy Homes remediation activities with weatherization activities achieves cost savings and better outcomes in improving the safety and quality of homes, and (2) collect information on the benefits of coordinating with DOE, evaluate if improved health outcomes are achieved, and provide information on the replicability and sustainability of these models. This information collection request is to collect information on the potential benefits of coordinated service delivery by HUD's Lead Hazard Control Program and DOE's Weatherization Assistance Program grantees and subgrantees.

<u>Respondents</u>: Lead Hazard Control (LHC) Grantees; Weatherization Assistance Program (WAP) Grantees; and residential property owners or residents (renters).

<u>Total Burden Estimate:</u> The table below reflects our estimate of the burden on the LHC and WAP grantees, and the residents that will be recruited.
