Supplemental Notice of Technical Conference

As announced in the Notice of Technical Conference issued in the above-referenced proceeding on April 23, 2021, the Federal Energy Regulatory Commission (Commission) will convene a Commissioner-led technical conference on Wednesday, June 23, 2021 and Thursday, June 24, 2021, from approximately 12:30 p.m. to 5:00 p.m. (Eastern Time) each day.
