**Notice of Request for Renewal of an Approved Information****Collection: *Salmonella* Initiative Program**

**AGENCY:** Food Safety and Inspection Service (FSIS), U.S.

Department of Agriculture (USDA).

**ACTION:** Notice and request for comments.

**SUMMARY:** In accordance with the Paperwork Reduction Act of 1995 and the Office of Management and Budget (OMB) regulations, FSIS is announcing its intention to renew the approved information collection regarding the *Salmonella* Initiative Program (SIP). FSIS is making no changes to the current collection. The approval for this information collection will expire on February 29, 2024.

**Abstract:** FSIS has been delegated the authority to exercise the functions of the Secretary (7 CFR 2.18 and 2.53), as specified in the Federal Meat Inspection Act (FMIA) (21 U.S.C. 601, et seq.), the Poultry Products Inspection Act (PPIA) (21 U.S.C. 451, et seq.), and the Egg Products Inspection Act (EPIA) (21 U.S.C. 1031, et seq.). These statutes mandate that FSIS protect the public by verifying that meat, poultry, and egg products are safe, wholesome, and properly labeled and packaged.

FSIS is requesting renewal of the approved information collection regarding the *Salmonella* Initiative Program (SIP). FSIS is making no changes to the current collection. The approval for this information collection will expire on February 29, 2024.

Through SIP, FSIS offers incentives to meat and poultry slaughter establishments to control *Salmonella* in their operations. Under SIP, FSIS does this by granting waivers of certain regulatory requirements under the condition that establishments test for *Salmonella*, *Campylobacter* (if applicable), and an Aerobic Count for other indicator organisms and share all sample results with FSIS. In return for meeting the conditions of SIP, the Agency grants establishments appropriate waivers of certain regulatory requirements, based upon establishment proposals and documentation, under FSIS regulations at 9 CFR 303.1(h) and 381.3(b). These regulations

specifically provide for the Administrator to waive for limited periods any provisions of the regulations to permit experimentation so that new procedures, equipment, or processing techniques may be tested to facilitate definite improvements. Establishments participating in SIP agree to the conditions of SIP regarding pathogen testing and sharing of test result data with FSIS.

FSIS has made the following estimates based upon an information collection assessment:

*Respondents:* Official slaughter establishments that are under a waiver.

*Estimated Number of Respondents:* 79.

*Estimated Number of Annual Responses per Respondent:* 325.

*Estimated Total Annual Burden on Respondents:* 17,628 hours.

All responses to this notice will be summarized and included in the request for OMB approval. All comments will also become a matter of public record. Comments are invited on: (a) whether the proposed collection of information is necessary for the proper performance of FSIS' functions, including whether the information will have practical utility; (b) the accuracy of

FSIS' estimate of the burden of the proposed collection of information, including the validity of the method and assumptions used; (c) ways to enhance the quality, utility, and clarity of the information to be collected; and (d) ways to minimize the burden of the collection of information, including through the use of appropriate automated, electronic, mechanical, or other technological collection techniques, or other forms of information technology.
