The information collection is necessary to understand whether the Enhanced, Assess, Acknowledge, Act Sexual Assault Resistance Training can be implemented with fidelity in the military as a primary prevention activity and whether it will produce beneficial outcomes. This information will help support the development of evidence-based approaches for prevention.
