### **Transcontinental Gas Pipe Line Company, LLC; Notice of Request Under Blanket Authorization and Establishing Intervention and Protest Deadline**

Take notice that on April 15, 2026, Transcontinental Gas Pipe Line Company, LLC (Transco), Post Office Box 1396, Houston, Texas 77251, filed in the above referenced docket, a prior notice request pursuant to sections 157.205, 157.208, 157.210, and 157.211 of the Commission's regulations under the Natural Gas Act (NGA), and Transco's blanket certificate issued in Docket No. CP82-426-000,<sup>1</sup> for authorization to:

- 1) install three new delivery meter stations and modify Transco's Station 35 located in Harris County, Texas; and
- 2) expand the existing Louisiana Southwest LW269 Valve Site located in Beauregard and Allen Parishes, Louisiana (Gillis West Expansion Project). The project will enable Transco to provide an incremental 115,000 dekatherms per day of firm transportation capacity from the existing Transco mainline in Beauregard Parish, Louisiana to the three proposed delivery points located in Harris County, Texas.<sup>2</sup>

The estimated cost for the project is \$28,697,634, all as more fully set forth in the request which is on file with the Commission and open to public inspection.

### **PUBLIC PARTICIPATION**

There are three ways to become involved in the Commission's review of this project: you can file a protest to the project, you can file a motion to intervene in the proceeding, and you can file comments on the project. There is no fee or cost for filing

protests, motions to intervene, or comments. The deadline for filing protests, motions to intervene, and comments is **5:00 pm Eastern Time on June 26, 2026**. How to file protests, motions to intervene, and comments is explained below.

### **Protests**

Pursuant to section 157.205 of the Commission's regulations under the NGA,<sup>3</sup> any person<sup>4</sup> or the Commission's staff may file a protest to the request. If no protest is filed within the time allowed or if a protest is filed and then withdrawn within 30 days after the allowed time for filing a protest, the proposed activity shall be deemed to be authorized effective the day after the time allowed for protest. If a protest is filed and not withdrawn within 30 days after the time allowed for filing a protest, the instant request for authorization will be considered by the Commission.

Protests must comply with the requirements specified in section 157.205(e) of the Commission's regulations,<sup>5</sup> and must be submitted by the protest deadline, which is **5:00**

**pm Eastern Time on June 26, 2026.** A protest may also serve as a motion to intervene so long as the protestor states it also seeks to be an intervenor.

### **Interventions**

Any person has the option to file a motion to intervene in this proceeding. Only intervenors have the right to request rehearing of Commission orders issued in this proceeding and to subsequently challenge the Commission's orders in the U.S. Circuit Courts of Appeal.

To intervene, you must submit a motion to intervene to the Commission in accordance with Rule 214 of the Commission's Rules of Practice and Procedure<sup>6</sup> and the regulations under the NGA<sup>7</sup> by the intervention deadline for the project, which is **5:00 pm Eastern Time on June 26, 2026**. As described further in Rule 214, your motion to intervene must state, to the extent known, your position regarding the proceeding, as well as your interest in the proceeding. For an individual, this could include your status as a landowner, ratepayer, resident of an impacted community, or recreationist. You do not need to have property directly impacted by the project in order to intervene. All timely, unopposed motions to intervene are automatically granted by operation of Rule 214(c)(1). Motions to intervene that are filed after the intervention deadline are untimely and may be denied. Any late-filed motion to intervene must show good cause for being late and must explain why the time limitation should be waived and provide justification by reference to factors set forth in Rule 214(d) of the Commission's Rules and Regulations. A person obtaining party status will be placed on the service list maintained by the Secretary of the Commission and will receive copies (paper or electronic) of all documents filed by the applicant and by all other parties.

### **Comments**

Any person wishing to comment on the project may do so. The Commission considers all comments received about the project in determining the appropriate action to be taken. To ensure that your comments are timely and properly recorded, please submit your comments on or before **5:00 pm Eastern Time on June 26, 2026**. **The filing of a comment alone will not serve to make the filer a party to the proceeding.** To become a party, you must intervene in the proceeding.

### **How to File Protests, Interventions, and Comments**

There are two ways to submit protests, motions to intervene, and comments. In both instances, please reference the Project docket number **CP26-218-000** in your submission.

(1) You may file your protest, motion to intervene, and comments by using the Commission's eFiling feature, which is located on the Commission's website ([www.ferc.gov](http://www.ferc.gov)) under the link to Documents and Filings. New eFiling users must first create an account by clicking on "eRegister." You will be asked to select the type of filing you are making; first select "General" and then select "Protest", "Intervention", or "Comment on a Filing"; or <sup>8</sup>
