Notice of Petition for Extension of Waiver of Compliance

AGENCY: Federal Railroad Administration (FRA), Department of Transportation (DOT).

ACTION: Notice.

SUMMARY: This document provides the public notice that the National Railroad Passenger Corporation (Amtrak) petitioned FRA for an extension of relief from certain regulations concerning ECP brake systems on passenger trains.

DATES: FRA must receive comments on the petition by **[INSERT DATE 60 DAYS AFTER DATE OF PUBLICATION IN THE FEDERAL REGISTER]**. FRA will consider comments received after that date to the extent practicable.

SUPPLEMENTARY INFORMATION: Under part 211 of title 49 Code of Federal Regulations (CFR), this document provides the public notice that by letter dated April 1, 2026, Amtrak petitioned FRA for an extension of a waiver of compliance from certain provisions of the Federal railroad safety regulations contained at 49 CFR parts 229¹ (Railroad Locomotive Safety Standards) and 238 (Passenger Equipment Safety Standards). FRA assigned the petition Docket Number FRA-2015-0078.

Amtrak requests extended relief from 49 CFR § 238.109, *Training, qualification, and designation program* and § 238.311, *Single car test*. This relief permits Amtrak to continue operating four Amfleet I coach cars with ECP control valves beyond the 1,476-day clean, oil, test, and stencil interval per § 238.309(d)(2), *Periodic brake equipment maintenance – Passenger coaches and other unpowered devices*. Further, Amtrak requests modifications to several of the conditions in the June 14, 2019 decision letter related to geographic limitations, applicable brake rules, and reporting requirements.

Interested parties are invited to participate in these proceedings by submitting written views, data, or comments. FRA does not anticipate scheduling a public hearing in connection with these proceedings since the facts do not appear to warrant a hearing. If any interested party desires an opportunity for oral comment and a public hearing, they should notify FRA, in writing, before the end of the comment period and specify the

basis for their request.
